Owner agrees to pay training fee in full at the beginning of training.

Owner specifically represents that he/she is the sole owner of the dog and the dog is current on all necessary vaccinations and to the best of his/her knowledge is in good health.

Victory K-9 Inc. shall exercise reasonable care for the dog while in their control. It is expressly agreed by dog owner the Victory K-9 Inc. assumes no liability for injury, illness, or sickness while in their care.

It is expressly agreed that Victory K-9 Inc. assumes no liability for damage to person or property cause by the dog while in their care. The dog owner agrees to accept all liability and responsibility for the cost of any and all damages to person or property by their dog at all times.

If the dog becomes ill or the state of the animal's health otherwise requires professional attention, Victory K-9 Training Inc. in its sole discretion may engage the services of a veterinarian of their choosing or administer medicine or give other requisite attention to the animal as they deem appropriate, and all expenses shall be paid by the dog owner.

Owners who do not attend, participate or follow thru in owner handling training agree to waive all rights and claims regarding the dog's performance.

The dog owner specifically understands that dog training is behavior modification of both dog and owner for the desired results, and also requires modification of certain environments as well. This includes but is not limited to: completing owner handling sessions, following training instructions as outlined in training sessions and consistent daily practice with the dog. Owner further understands that not following training guidelines may produce negative results and may undo training taught by Victory K-9 Inc.

Victory K-9 Training Inc. goes beyond most trainers in assisting owners to be effective with their dogs. We never encourage hitting or abusive tactics. We make ourselves available for follow up questions and within reason, may offer an additional handler session if the need arises. These sessions are not for retraining due to handlers not working their dogs or not following handling instructions.

**AGREEMENT TO HOLD HARMLESS, WAIVER, AND ASSUMPTION OF RISK**

I hereby waive and release Victory K-9 Training, Inc., its owners, board members, agents, employees, officers, and members from any and all liability of any nature for injury or damage resulting from the action of this dog, including specifically, but without limitation, any injury or damage resulting from the action of any dog or person and I expressly assume the risk of such damage or injury while at any location or function or while on any grounds and surrounding area.
